



## **AN ORDINANCE DECLARING A ROAD CLOSURE AND ALLOWING SPECIAL EVENT ALCOHOL SALES FOR THE 2022 PITTSBORO STREET FAIR**

**WHEREAS**, the Town of Pittsboro acknowledges the Pittsboro Street Fair hosted by the Pittsboro Rotary Club is cherished autumn event for the pleasure of the citizens; and

**WHEREAS**, the Town of Pittsboro acknowledges its citizens realize the benefits from holding the Pittsboro Street Fair; and


**WHEREAS**, Pittsboro Street Fair will take place on Saturday, October 29, 2022 between the hours 10:00am and 4:00pm; and

**NOW THEREFORE BE IT ORDAINED**, by the Town of Pittsboro Board of Commissioners that the Town roads listed herein shall be closed and alcohol be allowed to be sold and consumed under the following conditions:

- The Special Event premises of the Pittsboro Street Fair shall be confined to the area shown in Exhibit A attached hereto and described as the property of Gunn & Messick, PLLC located at 90 W. Salisbury Street, the future Town Hall Site located at 50 W. Salisbury Street, the portion of W. Salisbury Street right-of-way from the Eastern edge of Credle Street extending eastward to the Western edge of Hillsboro Street, the portion of Credle Street right-of-way from the Northern edge of W. Salisbury Street to the Northern Edge of Hanks Street, and the portion of Hanks Street right-of-way from the Western edge of Credle Street extending eastward to the Western edge of Hillsboro Street.
- Pittsboro Street Fair setup shall not occur in any closed roadway in advance of 6:00am on Saturday, October 29, 2022. General event setup or temporary setup on the future Town Hall site located at 50 W. Salisbury Street shall not occur prior to 12noon on Friday, October 28, 2022. The setup of any vendor or merchant shall no occur in any roadway or the Town Hall lot in advance of 6:00am on Saturday, October 29, 2022.
- Pittsboro Street Fair shall remove of all event infrastructure, including but not limited to vendor stations, signs, traffic control measures, and litter and the site restored to its original condition by 6:00pm on Saturday, October 29, 2022.
- Pittsboro Street Fair shall serve all alcoholic beverages in plastic containers.
- Pittsboro Street Fair shall limit alcohol consumption to Special Event premises identified in Exhibit A.
- Pittsboro Street Fair shall not allow alcohol to be served or consumed in the Special Event premises prior to 10:00am and 4:00pm on Saturday, October 29, 2022.
- Pittsboro Street Fair shall not in any way use, alter, attach to, or otherwise affect the existing retaining wall or fencing on the Special Event premises.

- Pittsboro Street Fair shall secure proper insurance and issue hold harmless documentation in favor of the Town of Pittsboro and Gunn & Messick, PLLC for the Special Event.
- Pittsboro Street Fair shall secure any and all other permits required for the event.
